#### 2012 Eco-Tourism Summit

Titusville serves as the gateway for Merritt Island National Wildlife Refuge, Canaveral National Seashore, and Kennedy Space Center. Our community's future depends upon partnerships that protect our natural resources and promote sustainable economic development. This spring, Refuge Manager Layne Hamilton, Canaveral National Seashore Superintendent Myrna Palfrey, Titusville Mayor Jim Tulley, Titusville Area Chamber of Commerce President Marcia Gaedcke, and Dixie Crossroad Restaurant owner Laurilee Thompson formed a team to focus on eco-tourism based on local public lands. The team attended the Balancing Nature and Commerce workshop at the U.S. Fish and Wildlife Service's National Conservation Training Center in West Virginia in April

to learn how to capitalize on our environmental assets to promote the Titusville area as an eco-tourism destination while highlighting the community's symbiotic relationship between technology and the environment. The weeklong training focused on the concept of sustainable tourism and building the economy through partnerships with public lands, while maintaining the unique character of the community.

The next stage in this program is to host a local summit to engage the community in promoting sustainable economic development and a unified vision for Titusville. While the overarching theme is nature, the tools that this summit will bring to the community will be relevant to art and culture, retail development, transportation and many other areas and will dovetail directly with the work of the Greater Titusville Renaissance. Currently, the core team is working along with NASA Planner Mario Busacca, Brevard Cultural Alliance Executive Director Neil Levine, Aide to Commissioner Fisher Liz Lakovichaide, and Kris Hoellen from The Conservation Fund. Together they will develop an exciting and relevant program to be held in Spring 2012. This endeavor would not be possible if not for the financial support of MIWA, which funded the travel for three of the team members to West Virginia, and has agreed to co-sponsor the 2012 Titusville summit.

# 2011 MINWR Sea Turtle Nesting Survey

There are only a few weeks of sea turtle nesting season left. However, our sea turtles haven't received the memo and are still nesting strong. Leatherbacks are done for the year with 4 nests. Greens are shifting into high gear with 142 nests with Loggerhead nests totaling 1,066 thus far.

Last year the season started late and ended late so comparing numbers are like comparing oranges to tangerines. 2010 provided us with some of the highest numbers with 1,163 Loggerheads, 142 Greens, and 6 Leatherback reportable nests totaling 1,311 nests.

We are still averaging 10 nests daily and only 50 nests out of 1,212 nests have been predated by coyote, bobcat, raccoon, hog, or ghost crab this year. There are 299 nests to excavate so far. We are on pace to surpass last year's nesting season making this a successful year for us and our sea turtles.

# President's Message

Hello from the refuge! It is hot and rainy which means the impoundments are full of water and are doing a great job of raising the infamous salt marsh mosquito.

As you know one of the most important board meetings of the year occurs in the month of August. This is about two months before our new fiscal year. It is at this "Blue Sky" meeting were we address funding for refuge projects for the new year. As requested by refuge staff members, there are basically two groups of projects: **Routine projects** such as environmental education and volunteer programs that require continued funding from one year to the next. Then, there are **Special projects** that are specific for the fiscal year of 2012. These include funds for a local conference on balancing nature and commerce and a smoke and fire detection system for the VIC. You will be happy to know that we were able to provide funds for all requested projects from both categories. The cost of these

obligations amounted to about \$72,000. At this time, between savings, checking, money market accounts and projected net income in 2012 we have about \$100,000. This may be even higher if we receive a \$25,000 grant written and proposed by our refuge liason Dorn Whitmore. This grant will help pay for at least one-half the cost of our new minibus, which has been purchased, and is ready to go. We will keep you updated.

Please join us for a fun-filled evening at our Annual Meeting on October 12<sup>th</sup> @ 6 pm (see back page for details). There will be two keynote speakers, a silent auction, a refuge update and a wonderful dinner put on by Bill Moore of the Delaware North Parks and Resorts Corporation. A good time will be had by all. Hope to see you there.

# Deep Cuts to National Wildlife Refuges and Guts Key Land Acquisition, Grant, and Climate Change Programs

A 21% cut to the U.S. Fish and Wildlife Service and 8% cut to Refuges, will result in the closure of 140 Refuges, elimination of 300 Refuge staff positions, elimination of any new land acquisitions and conservation easements and prevent any new endangered species listings.

Washington, DC—The National Wildlife Refuge Association (NWRA) was stunned over the House Interior Appropriations Subcommittee's proposed \$37 million cut to the National Wildlife Refuge System's budget as part of an overall 21% cut to the U.S. Fish and Wildlife Service, the agency charged with overseeing the 150 million acre system.

"Despite the extraordinary economic, ecological and public benefits that come from conservation funding, the House has chosen to slash an already meager Refuge System and natural resources budget," said Evan Hirsche, President of the National Wildlife Refuge Association. "By doing so, Congress threatens America's clean air and water and safe places families depend on for recreation and renewal."

The Cooperative Alliance for Refuge Enhancement, or CARE, a diverse coalition of conservation and sporting organizations chaired by NWRA, estimates the System needs at least \$900 million annually to properly function. The House proposal would be just over half that much at \$452 million and would mean 140 refuges would close, 300 positions would be eliminated and critical habitat restoration projects would not be completed, growing the already enormous backlog of operations and maintenance needs.

The House plan would also slash the Land and Water Conservation Fund (LWCF) by 80% to the lowest level in its 45-year history with only \$11 million for the Refuge System; barely enough to finish projects started this fiscal year. This level of funding would bring Refuge System land acquisition projects to a screeching halt leaving hundreds of private landowners seeking to sell their land or obtain conservation easements in limbo. Further, such a cut violates a trust with the American people as LWCF revenues are derived from small percentage of offshore oil and gas lease receipts and intended as reciprocation for extraction of resources from the public domain.

"The LWCF is one of the strongest tools a land manager has to protect key habitats and promote good will in communities," said Hirsche. "Drastic cuts to LWCF not only hurts wildlife, but also hard working farmers and ranchers who seek conservation easements that help protect wildlife habitat while also allowing them to stay on the land and keep family business intact."

The bill further proposes to eliminate funding for the Neotropical Migratory Bird Fund and drastically reduce funding for climate change programs, the North American Wetlands Conservation Act (NAWCA), which funds wetland restoration on refuges, the State Wildlife Grants program that helps states keep species from becoming endangered and

the Partners for Fish and Wildlife Programs which helps the Fish and Wildlife Service (FWS) work directly with private landowners. Further, the bill takes aim at bedrock environmental laws including the Endangered Species Act; language in the bill prohibits the FWS from any new endangered species listing.


NWRA is asking Congress to fund the Refuge System at \$511 million in Fiscal Year 2012, level funding from FY 2010. NWRA, it's conservation partners in CARE and more than 230 local "Refuge Friends" groups will work with Congress to restore funding for the Refuge System in any final FY 2012 spending bill.

## Jr. Ranger Summer Fun



Children ages 6-9 and their families were invited to attend MINWR's free Summer Jr. Ranger Program. Programs included: Owls and Owl Pellet dissection, Seining the Indian River Lagoon, Freshwater Pond Exploration, Fascinating Reptiles and All About Manatees. MIWA sponsored the program through the purchase of supplies and hiring guest speakers. The audience was treated to encounters with live animals including screech and barred owls from the Florida Wildlife hospital, the rarely seen brackish water turtle, the diamond-backed terrapin, a young alligator and Buddy, the Red-rat snake.

Parents and children explored together the environmental topics through hands on activities including dissecting owl pellets containing animal skeletons and using seine nets to catch and study and then release the near shore life of the Indian River Lagoon such as sea horses, pipe fish and blue-clawed crabs. The children explored the fresh water pond using dip nets to capture dragonfly nymphs, freshwater shrimp, and diving beetles. During the culminating event, several students presented their independent projects. Several children built screech owl nesting boxes

while others researched a topic, created a poster and presented it to the audience. Jr. Rangers that completed the program requirements received a Jr. Ranger Certificate at the award ceremony along with a MINWR patch and pin. Afterwards, newly crowned Jr. Rangers celebrated by eating cupcakes and cookies with their new refuge friends.




# The Highs and Lows of Turtle Walks


